

## MINUTES of Deep Fork Valley Football Association Meeting

Meeting date: 1/19/11

### New business:

The Floor was opened for nominations for the office of treasurer. The Incumbent did not seek re-election. Gary Knowles was nominated by Noble. Seconded by Blanchard. Knowles was elected treasurer of DFV.

The floor was then opened for nominations for the office of secretary. The Incumbent did not seek re-election. Jeremy Quarry was nominated by Prague. Seconded by Meeker. Quarry was elected secretary of DFV. The floor was then opened for nominations for office of vice president. The incumbent did not seek re-election. Casey Martin was nominated by Prague. Seconded by Meeker. Martin was elected vice president of DFV. The floor was then opened for nominations for the office of president. Incumbent Kenneth Crawford was nominated by Choctaw, seconded by McLoud. Crawford retained the office of president of DFV.

Crawford opened the floor for discussion for the formation of committees to regulate DVF operations. It was motioned by Harrah and seconded by Chandler to form five committees:

1. Bi-law committee consisting of Tecumseh, Noble, and Perkins.
2. Rules/safety committee consisting of Seminole, Newcastle, Chandler, Prague (Jeremy Quarry).
3. League expansion committee consisting of Choctaw, Prague, McLoud, and Meeker.

4. Referee/scheduling committee consisting of Harrah, Tecumseh, Nicoma Park, McLoud

5. Post season committee consisting of Jones, Luther, Nicoma Park, and Blanchard

Motion carried.

Motion was made by Chandler to allow Player A (individual player names will not be posted – ask your Coordinator) to play football at Mcloud, seconded by Jones. Voting was carried out by closed ballot.

Motion carried.
