

MINUTES of Deep Fork Valley Football Association Meeting

Meeting date: 3/30/2011

1. **Call to order:** A regular meeting of the DEEP FORK VALLEY FOOTBALL LEAGUE was held at 1700 W. Independence, Shawnee, Oklahoma. The meeting convened at 6:41PM, President Kenneth Crawford presiding, and Jeremy Quarry, secretary.

A motion was made by Noble to keep championship games in Choctaw and Nicoma Park for 2011. Motion seconded by Jones. Motion passed 14 -0. Discussion was held on the possibilities of a state wide tournament, and scheduling meetings with other leagues.

Referee/Schedule Committee: Chairman- Mike Keisel. Discussion was held on starting a data bank of referee's information to give DFVLA its own pool of referees. A motion was made by CNP to raise referee's pay per game from \$30 to \$35 per game. The motion was seconded by Chandler. Motion was voted to 7-7 tie. President, Kenneth Crawford, voted yes to pass the motion pass 8-7. A motion was made by CNP to retain the services of Tom Davis to provide referees for the 2011 season, and provide a form to collect personal information and to critique referees to start a data base. The motion was seconded by Blanchard. Motion passed 14-0.

Rules/Safety Committee: Chairman- Chris Hammond. Discussion was held on weight limits, point after attempts and field goals. The committee's proposal was tabled until next meeting.
